### "Election of Directors"

#### (Excerpted from By Laws of Grady EMC Directors)

SECTION 4.01. NUMBER AND GENERAL POWERS. The business and affairs of the Cooperative shall be managed by a Board of seven (7) Directors. The Board shall exercise all of the powers of the Cooperative except such as are by laws or by the Cooperative's Articles of Incorporation or Bylaws conferred upon or reserved to the member. The Board of Directors shall not appoint or elect any committee to exercise the authority of the Board. However, the Board may appoint or elect from its own membership one or more committees, each consisting of at least two directors, for the purpose of serving in an advisory or recommendatory capacity to the Board.

SECTION 4.02. QUALIFICATIONS. No person shall be eligible to become or remain a director of the Cooperative who is a close relative of an incumbent director or of an employee of the Cooperative, or is not a member in good standing of the Cooperative and receiving service therefrom at his primary residential abode: PRO-VIDED, that the operating or chief executive of any member which is not a natural person, such as a corporation, church, etc., or his designee, shall notwithstanding that he does not receive service from the Cooperative at his primary residential abode, be eligible to become a director, from the Directorate District in which such member is located, if he or such designee (1) is in substantial permanent occupancy, direction or use of the premises served by the Cooperative, and (2) is a permanent and year round resident within or in close proximity to an area served by the Cooperative; BUT PRO-VIDED FURTHER, that no more than one (1) such person may serve on the Board of directors at the same time. No person shall be eligible to become or remain a director of, or to hold any other position of trust in, the Cooperative who is not at least (18) years of age or is in any way employed by or financially interested in a competing enterprise or a business selling electric energy or supplies to the Cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies, to among others the members of the Cooperative. Notwithstanding any of the foregoing provisions of this Section treating with close relative relationships, no incumbent director shall lose eligibility to remain a director or to be re-elected as a director if he becomes a close relative of another incumbent director or of a Cooperative employee because of a marriage to which he was not a party. Upon establishment of the fact that a nominee for director lacks eligibility under this Section or as may be provided elsewhere in these Bylaws, it shall be the duty of the chairman presiding at the meeting at which such nominee would otherwise be voted upon to disqualify such nominee. Upon the establishment of the fact that any person being considered for, or already holding, a directorship or other position of trust in the cooperative lacks eligibility under this section, it shall be the duty of the Board of Directors to withhold such position from such person, or to cause him to be removed therefrom, as the case may be. Nothing contained in this Section shall, or shall be construed to, affect in any manner whatsoever the validity of any action taken at any meeting of the Board of Directors, unless such action is taken with respect to a matter which is affected by the provisions of this Section and in which one or more of the directors have an interest adverse to that of the Cooperative.

SECTION 4.03 ELECTION. At each annual meeting of the members, directors shall be elected by secret written ballot by the members and, except as provided in the first proviso of Section 4.02 of these Bylaws, from among those members who are natural persons: PROVIDED that, Directors shall be elected by a plurality of the votes cast. Drawing by lot shall resolve, where necessary, any tie votes.

SECTION 4.04. TENURE. Directors shall be so nominated and elected that one director from or with respect to Directorate Districts Nos. 3 and 6 shall be elected for three-year terms at an annual member meeting in 2002; one director from or with respect to directorate districts Nos. 1, 4, and 7 shall be elected for three-year terms at the next succeeding annual member meeting in 2003; one director from or with respect to Directorate district Nos. 2 and 5 shall be elected for three-year terms at the next succeeding annual member meeting in 2004, and so forth. Upon their election, directors shall, subject to the provisions of these Bylaws with respect to the removal of directors, serve until the annual meeting of the members of the year in which their terms expire or until their successors shall have been elected and shall have qualified. If for any reason an election of directors shall not be held at an annual meeting of the members duly fixed and called pursuant to these Bylaws, such election may be held at an adjournment of such meeting or at a subsequently held special or the next annual meeting of the members. Failure of an election for a given year shall allow the incumbents whose directorships would have been voted on to hold over only until the next member meeting at which a quorum is present.


# Nominations of Directors Article IV of The By-Laws Of The Grady EMC

SECTION 4.06. NOMINATIONS. It shall be the duty of the Board of Directors to appoint not less than sixty (60) nor more than ninety (90) days prior to the date of a meeting of the members at which directors are to be elected, a Committee on Nominations, consisting of not less than eight (8) nor more than twelve (12) members of the cooperative who are not existing Cooperative employees, agents, officers, directors or known candidates for director, who are not close relatives (as hereinafter defined) or members of the same household thereof, and who are so selected that each of the Cooperative's directorate districts shall have representation thereon in proportion to the number of authorized directors from or with respect to such District. The Committee shall prepare and post at the principal office of the Cooperative at least thirty (30) days prior to the meeting a list of nominations for directors to be elected, listing separately the nominee(s) for each Directorate District from or with respect to which a director must, pursuant to this Article, be elected at the meeting. The Committee shall include two (2) nominees for each Directorate District. Any fifteen (15) or more members of the Cooperative, acting together, may make additional nominations in writing over their signatures, listing their nominee(s) in like manner, not less than twenty (20) days prior to the meeting, and the Secretary shall post such nominations at the same place where the list of nominations made by the Committee is posted. The Secretary shall mail to the members with the notice of the meeting, or separately, but at least five (5) days prior to the date of the meeting, a statement of the names and addresses of all nominees for each Directorate District from which directors must be elected, showing clearly those nominated by the Committee and those nominated by petition, if any. Nominations shall be closed at 5:00 p.m. on the date twenty (20) days before the meeting. Candidates failing to be placed on the ballot through nominations shall have the opportunity of running for the Board as write-in candidates. Any member desiring to vote for a member not nominated may vote for such person by writing in such person's name on the ballot. All ballots shall provide space for the names of such candidates. Notwithstanding the provisions contained in this Section, failure to comply with any such provisions shall not affect in any member whatsoever the validity of any action taken by the Board of Directors after the election of directors.

#### **Nominating Committee Meeting**

The Nominating Committee is scheduled to meet September 12, 2002 at 10:00 a.m. at the Grady EMC office building. They will appoint designated names from each district in which two of whom will be elected as Directors of Grady Electric Membership Corporation. The Board of Directors met August 7 and approved the following names as the 2002 Nominating Committee:

# Chairman and Manager's Report

m sure everyone has been watching the news for the last several months and wondering what is happening to the corporate world. The driving force behind the troubles of Enron and WorldCom, and the problems other utilities are having are a direct result of GREED. The wall street types have been saying for several years that the cooperative form of doing business is dead; however, the cooperative form of business does not allow anyone to benefit at the expense of the member/owner/customer. Cooperatives don't have stock; therefore no stock options, no stock market. There is no incentive to inflate earnings or decrease expenses to impress the Wall Street people. Our incentive is to keep the lights on at the best price to our member/owners. Our "profits" are called margins, and eventually are returned to our member/owners in the form of capital credits, which are not taxed. Last year (2001), we returned \$176,614.49 to the estates of our deceased members, and we returned \$193.563.94 in 2000.

Some of our newer members may not understand what they are a part of, but the bottom line is they are a part of the best form of doing business today. We have the ability to use our size to negotiate on your behalf, to provide reliable power at a reasonable cost, and to be responsive to your needs through your direct access to your elected board member. Your rates are the same as they were in 1992. We may not always be the cheapest, but we always plan on being the best, and we always have your best interest in mind.

Calendar year 2001 ended with 13,758 members, our margins remained steady, and progress continued on converting the system to 25,000 volts. The conversion should be completed in the next two years. We have approximately 50% of the meters changed so they can be read from the office, and our right—of—way program is still on a five-year rotation. Electricity, the best bargain; cooperatives, the best form of governance.

Grady EMC's directors and employees are proud of the job they are doing to provide quality, dependable power to the members, and will continue to do what it takes to provide that service.

Through the guidance of your elected Board of Directors, Grady EMC is continually striving to find better and less expensive ways to provide you the service you expect. Remember, this is YOUR cooperative. Your Board of Directors and employees welcome you to the 64th Annual Meeting of your Co-op.


### **Secretary and Treasurer's Report**


