Deposits
<p>A deposit may be charged to any customer, existing or new, who fails to meet Grady EMC's credit requirements, as determined through the Online Utility Exchange, or who has been delinquent for two months out of a three month period. At termination of service, the deposit will be applied to the unpaid balance of any outstanding bill, and the remainder of the deposit, if any, will be refunded to the customer. No deposit is required for new customers with a qualified credit rating.</p> <p>Should a new customer require a deposit, its amount shall be based on the calculated expected amount of the bill.</p> <p>Should an existing customer require a deposit, its amount shall be based on the most recent twelve month period. If the customer has been connected for a period shorter than twelve months, the amount shall be based on his/her tenure of service or the previous average bill at the location.</p> <p>Upon a member's request, a deposit may be refunded if the account has NOT been delinquent over the most recent 24 month period.</p> <p>The deposit minimum is \$300.00.</p>
