## **APPLICATION FOR ELECTRIC SERVICE**

The undersigned, hereinafter called the "Applicant", hereby applies for membership and agrees to purchase electric energy from Grady Electric Membership Corporation, hereinafter called the "Association", upon the following terms and conditions, to wit:

The Applicant will pay to the Association the sum of \$5.00, which will constitute the Applicant's membership fee. The Applicant expressly agrees that the Association may use the \$5.00 for the development and construction and operation of its rural distribution lines. The \$5.00 shall be refunded when the Applicant terminates his membership, or said \$5.00 shall be used to offset any unpaid sum due from Applicant to Association.

The Applicant, when electric energy becomes available and the meter is installed, will purchase from the Association all electric energy used on the premises described in the contract, and will pay monthly under the applicable rates of the Association in effect on date of contract. In the event that said rate and minimum bill requirement is amended or changed by the Board of Directors of the Association, the Applicant agrees to pay the amount required for said rate and for the minimum bill as may be changed or amended.

The applicant will comply with and be bound by the provisions of the charter and by-laws of the Association, and such rules and regulations as may from time to time be adopted by the Association, or hereafter adopted by the Association.

By the execution of this application, Applicant grants unto the Association, its employees and agents, the right to go to, across and upon Applicant's property for the purpose of servicing and providing utility service to Applicant, and to supervise and maintain its operation, which includes right-of-way brush and tree maintenance.

Applicant shall pay to Association in accordance with Association's standard billing procedure all charges by Association in providing service to Applicant.
