MINUTES OF MEETING OF BOARD OF DIRECTORS OF GRADY ELECTRIC MEMBERSHIP CORPORATION HELD NOVEMBER 8TH, 2023

The regular meeting of the Board of Directors of Grady Electric Membership Corporation was held at its office in Cairo, Georgia, on the 8th day of November 2023. All Directors were present. Also present were President John Long, Attorney James Thagard, Clay Ulmer, Kyle Henderson, Terry Jones, Adam Starr, and Ansley Johnson.

- 8. **Annual Meeting Review.** The 85th Annual Meeting was held on October 20th, where 608 members were registered. Director Lee Powell was elected for District 3 and Director Jimmy Hammett was elected for District 6.
- 9. **Financial Report.** The Directors reviewed the financial report for September as presented by Clay Ulmer.
- 10. **CEO Report.** President John Long presented the CEO report.
 - a. Long reported copper was stolen from the Hwy 112 property earlier this month. The suspect was identified, and cameras have since been installed.
 - b. Grady EMC was featured in an article in the Georgia Magazine in November that highlighted Grady EMC's storm preparation and effort to cross-train employees.
 - c. Conexon is aiming to have the first customer connected by November 23rd, 2023. Make Ready Engineering crews are currently working in Elpino, while Make Ready Construction crews are in Reno. Crews will be moving to Brumbley Creek next. Main line fiber is being installed in Roddenberry. 67.36 miles of fiber have been installed to date.
