## MINUTES OF MEETING OF BOARD OF DIRECTORS OF GRADY ELECTRIC MEMBERSHIP CORPORATION HELD September 5, 2018

The regular meeting of the Board of Directors of Grady Electric Membership Corporation was held at its office in Cairo, Georgia, on the 5<sup>th</sup> day of September, 2018. All seven of the Directors were present. Also present were Interim President John Long, Attorney M. Claire Chason, Pat Reed, Keith Harrell, Kyle Henderson, and Adam Starr.

The meeting opened with an invocation and Pledge of Allegiance. Interim President John Long welcomed the live stream viewers. The Chairman presided, and the minutes were kept under the direction of the Secretary.

Chairman Stuckey called the meeting to order and announced that a check of qualifications of Directors and nominees for Directors in the upcoming election had been performed, and it was reported that Director Gordon Clyatt had removed himself from the membership account of his primary residential abode. A majority of the Directors determined that Clyatt was no longer eligible to serve as a Director under Article IV. Section 4.02. of the Grady EMC By-Laws and voted to remove Clyatt from his directorship. Clyatt was recused. Directors Sellers and Donaldson objected. Clyatt was excused from the meeting.

The minutes of the previous regular meeting held on August 1, 2018, were read and approved.

Stone was nominated by petition in District 4.

- 6. **2018 Power Requirements Study and Load Forecast.** The Directors reviewed and approved the 2018 Power Requirements Study and Load Forecast as same was presented by Keith Harrell.
- 7. Safety Accreditation. Grady EMC received the Georgia EMC Electric Coop. Safety Accreditation Award for an outstanding safety program.
- 8. **Delegate/Representative Elections.** After discussion, the Directors elected John Long to fill the unexpired 2018 terms of the following positions formerly held by Bo Rosser:
